TASK 1: ASSIST WITH BASIC INDUSTRIAL ROPE ACCESS SYSTEMS (knowledge of anchors and knots)		Competent or Not Yet Competent	
<p>NOTE Assessor to ask the candidate to assist them to set up a rope access system which contains, but not limited to, 2x vertical ropes with knots (in both lines), another 2x vertical ropes which run through a re-direction and another 2x vertical ropes which run through a re-belay anchor point. The configuration of this rope access system may vary to suit the site. The Assessor is to check that the rope access system is safe for use by candidates.</p> <p>Candidate is to:</p>

TASK 2: CARRY OUT ELEMENTRY ON-ROPE SKILLS (challenge course)		Competent or Not Yet Competent	
<p>NOTE Assessor is to brief candidate on the on-rope skills to be demonstrated. This is best achieved by asking the candidates to complete a “challenge course” which requires them to demonstrate all the skills required, whilst maintaining safe position of back-up device and attachment to a minimum of 2x ropes at all times.</p> <p>Candidate is to:</p>

TASK 3: CARRY OUT SIMPLE PATIENT RECOVERY TECHNIQUE (descent rescue)		Competent or Not Yet Competent	
<p>NOTE Assessor is to brief candidate on the patient recovery scenario. Patient to be attached to 2x ropes (no knots) and positioned approx. 6m above the ground. Patient to be in their descending equipment and role play an “unconscious” patient and/or someone who has loaded their back up device. Candidate is to keep a safe position of back-up device(s) and ensure that they (and their patient) remain attached to a minimum of 2x ropes at all times.</p> <p>The rescue must be completed within 10 minutes:</p> <ul style="list-style-type: none"> time starts when the patient is in position and the candidate is on the ropes, in their descending equipment and 1m off the ground time ends when the patient is safely on the ground (not suspended in their harness) and the candidate is disconnected from the rope access system. <p>NOTE: Candidates may only use equipment that they “would normally carry on their harness”. Any rescue equipment must be worn the entire day.</p> <p>Candidate is to:</p>			
4.1	<p>Assess the situation involving recovery by rope:</p> <p>a) Identify all hazards associated with a rope rescue scenario</p> <p>b) Explain controls that could be used to manage the hazards</p>	C C	NYC NYC
4.2	<p>Prepare patient for descent:</p> <p>a) Demonstrate safe ascent / descent to reach the patient</p> <p>b) Position patient securely for descent (2x connections at all times)</p>	C C	NYC NYC
4.3	<p>Descend with patient and apply basic first aid:</p> <p>a) Demonstrate ability to descend safely with an unconscious patient (ie. so that the patient’s head is kept above their waist)</p> <p>b) Rescue is complete in less than 10 minutes</p>	C C	NYC NYC
